

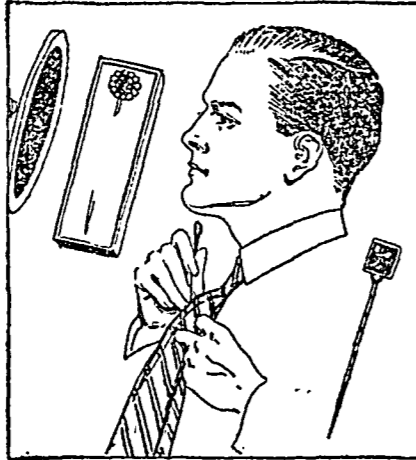

THE STATE OF MONTANA sends Greetings to the Above Named Defendants and to Each of Them:

You are hereby summoned to answer to the complaint in this action filed in the office of the Clerk of this Court, a copy of which is hereby served upon one of you in each county wherein any of you reside, or to file an answer and serve a copy thereof upon the plaintiff's attorney within twenty days after service of this summons, exclusive of the day of service, and in case of your failure to appear or answer, judgment will be taken against you by default for the relief demanded in the complaint.

This action is brought for the purpose of obtaining a decree of the Court for the foreclosure of a certain real estate mortgage covering real estate located in Teton County, Montana and described as follows:

The southwest quarter (SW 1/4) of Section two (2) in township twenty-four (24) North of Range two (2) West of the Montana Meridian.

Said mortgage was made, executed and delivered by Christian Filtenborg and Anne Filtenborg, his wife, dated December 1, 1920, to E. J. Lander & Co., a corporation, the plaintiff herein, which said mortgage was duly filed and recorded in the office of the County Clerk and Recorder of Teton County Montana on the 28th day of December A. 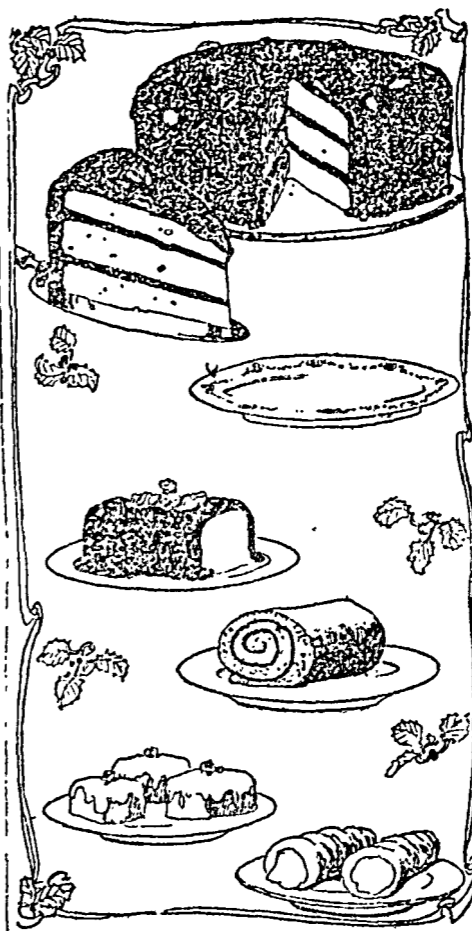
